The Government of Mozambique, represented by the Maputo Municipal Council has received financing from the World Bank, toward the cost of the Maputo Urban Transformation Project and intends to apply part of the proceeds for consulting services for Supervision of Construction Works of the Access Road to the KaTembe Sanitary Landfill.

The Consulting Services (“the Services”), will assist the Client in: (i) Review of the Construction Project; (ii) Supervision of Construction Works; (ii) Supervision of the replacement of Infrastructures affected by the construction of the Access Road; (iii) Supervision of the implementation of the Environmental and Social Safeguards Instruments, namely: (a) Environmental Management Plan (EMP) and the Social Compensation Plan (SCP) within the scope of the project. The duration of the contract is: 12 months for construction works, plus 12 months during defects liability period. The detailed Terms of Reference (TOR) for the assignment as well as further information can be obtained by sending a request to the email given below.

The Maputo Municipal Council now invites eligible consulting firms to express their interest in providing the Services. Interested Consultants shall provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: (i) Experience in Supervision of Roads and Bridges Construction Works; (ii) Experience of at least 10 similar projects in developing countries, including Mozambique; (iii) Familiar in World Bank Environmental and Social Safeguards Policies, as well as other applicable World Bank Environmental, Health and Safety Guidelines. Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.13, 3.15, and 3.16 of the World Bank’s “Procurement Regulations for IPF Borrowers”, 6<sup>th</sup> Edition, February 2025, setting forth the World Bank’s Policy on Conflict of Interest.

Consultants may associate with other firms to enhance their qualifications and shall indicate clearly whether the association is in the form of a joint venture or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost-based Selection (QCBS) method set out in the Procurement Regulations.
